THIS DEED OF NAME CHANGE which is intended to be recorded in the Island Record Office, Spanish Town, Saint Catherine of the Island of Jamaica, by us the undersigned **LATOYA NICOLA IRVING** of 3371 Hatfield Road, Waterford P.O., in the parish of St. Catherine and **DENROY GRAY** of 3371 Hatfield Road, Waterford, St. Catherine, the biological mother and father respectively of minor **BRIANNA NATOYA GRAY**, of 3371 Hatfield Road, Waterford P.O., in the parish of St. Catherine, being born on Thirtieth January, 2010 and registered on the Thirtieth January, 2010 on birth record bearing entry number AA 7356 in the parish of Kingston as **GAVEYONA NATOYA HARRIS GRAY**, and entered on the 10th May 2013 on Deed Poll Liber New Series 10449 Folio no. 99 as **BRIANNA NATOYA IRVING** where previous deed poll was drafted by **LATOYA NICOLA IRVING** as Mother and where her Father's name **DENROY GRAY** did not appear on the Birth Certificate stated above, **WITNESSES AND DECLARES** as follows:

We do hereby on behalf of the said **BRIANNA NATOYA GRAY** absolutely renounce and abandon the use of the name of **GAVEYONA NATOYA HARRIS GRAY** as appear on her birth record and **BRIANNA NATOYA IRVING** as appear on her previous deed poll and in lieu thereof on her behalf assume, adopt and determine to take and use from the date hereof the name of **BRIANNA NATOYA GRAY**.
2. THE said **BRIANNA NATOYA GRAY** will at all times hereafter in all records, deeds, documents and other writings and in all actions, suits, and as well as in all dealings and transactions, matters and things whatsoever and upon all occasions use and subscribe the said name of **BRIANNA NATOYA GRAY** in SUBSTITUTION of her former names of **GAVEYONA NATOYA HARRIS GRAY** and **BRIANNA NATOYA IRVING** which has been abandoned and renounced aforesaid to that intent.
3. We on behalf of the said **BRIANNA NATOYA GRAY** expressly authorise and require all persons whomsoever at all times to designate, describe and address the said **BRIANNA NATOYA GRAY** by the adopted name and not by the former names of **GAVEYONA NATOYA HARRIS GRAY** and **BRIANNA NATOYA IRVING**.

We submit that the change of name as evidenced by this DEED POLL is for the best interest of our child **BRIANNA NATOYA GRAY** and also for her benefit. We would like for her to retain her connection and identity with her biological father.

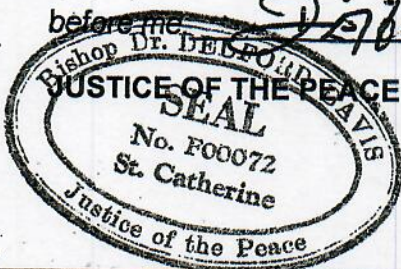

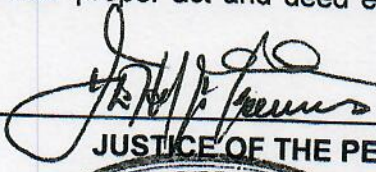
