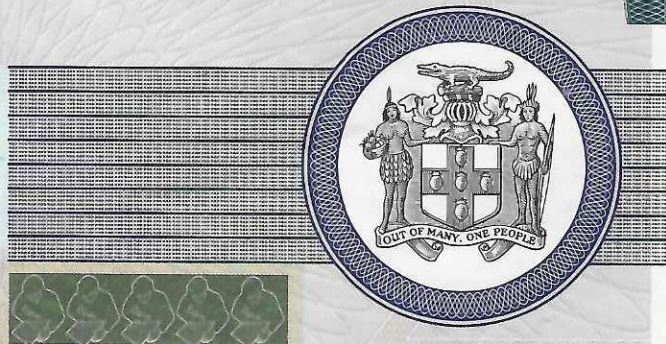

3. I on behalf of the said **JORDAN NICKOY POWELL** expressly authorise and require all persons whomsoever at all times to designate, describe and address the said **JORDAN NICKOY POWELL** by the adopted name and not by the former name of **JORDAN NICKOY ANNIKIE**.
