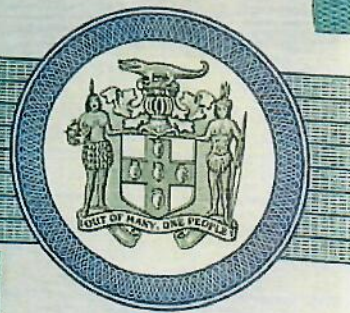

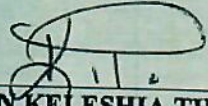
KNOW ALL MEN BY THESE PRESENTS which is intended to be recorded in the Island Record Office, Spanish Town, St. Catherine of the Island of Jamaica, by us the undersigned **KIZAN KELESHIA THOMAS**, Teacher of 28½ Waterloo Avenue, Kingston 10 in the parish of St. Andrew and **MARCUS GEORGE WEISE**, Businessman the mother and father of minor **NATHANIA NAPHTALI-ANNE WEISE** of the same address being born on the Fourth day of June, 2009 and registered on the Fifth day of June, 2009 on birth record with entry IA 8925 in the Public General Hospital, Mandeville in the parish of Manchester who is a child, single and a Jamaican National, WITNESSETH AND DECLARE as follows:-

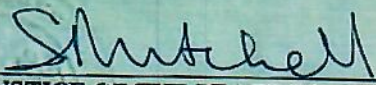

3. We on behalf of the said **NATHANIA NAPHTALI-ANNE WEISE** expressly authorize and require all persons whomsoever at all times to designate, describe and address the said **NATHANIA NAPHTALI-ANNE WEISE** by the adopted name and not by the former name **NATHANIA NAPHTALI-ANNE THOMAS WEISE**.

WE submit that the change of name as evidenced by this DEED POLL is for the best interest of our child and also for her benefit due to the fact that she was wrongfully registered by us with the Christian, Middle and Surname being presented.

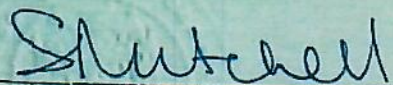
