1. We do hereby on behalf of the said **MACEY TAMEENA IBAHRI** absolutely renounce and abandon the use of the name **MACEY TAMEENA SMITH** and in lieu thereof on her behalf assume, adopt and determine to take and use from the date hereof the name of **MACEY TAMEENA IBAHRI**.

The said **MACEY TAMEENA IBAHRI** will at all times hereafter in all records, deeds, documents and other writings and in all actions, suits, and as well as in all dealings and transactions, matters and things whatsoever and upon all occasions use and subscribe to the said name of **MACEY TAMEENA IBAHRI** in SUBSTITUTION for her former name of **MACEY TAMEENA SMITH**.
3. We on behalf of the said **MACEY TAMEENA IBAHRI** expressly authorise and require all persons whomsoever at all times to designate, describe and address the said **MACEY TAMEENA IBAHRI** by the adopted name and not by the former name of **MACEY TAMEENA SMITH**.

We submit that the change of name as evidenced by this Deed Poll is for the benefit of our child **MACEY TAMEENA IBAHRI**. We declare that this change of name will in no way affect her identity with her biological father.
